**Plaintiffs' Second Motion Temporary Restraining Order
and Preliminary Injunction**

Pursuant to Fed. R. Civ. P. 65 and LCvR 65.1, Plaintiffs move for a temporary restraining order and a preliminary injunction to (1) enjoin the UCR Plan Board from further violating the Sunshine Act; (2) enjoin the UCR Plan Board to comply with the UCR Agreement and ordered to open the 2018 UCR Renewal Period immediately; and (3) order the Indiana Department of Revenue to open the UCR Renewal Period for 2018 immediately and enjoin it from refusing to accept UCR registration and payment of UCR fees for 2018. Plaintiffs respectfully request that this Court immediately order that Defendant UCR Plan Board comply with the Sunshine Act for its prospective November 30, 2017 meeting.

In support of this motion, Plaintiffs file contemporaneously its *Memorandum in Support of Plaintiffs' Second Motion for Temporary Restraining Order and Preliminary Injunction*. A draft order is provided. LCvR 7(c). Oral argument on this motion is requested. LCvR 7(f).
